

SAVOR YOUR SUMMER INSTANT WIN GAME AND SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. MAKING A PURCHASE WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Savor Your Summer Instant Win Game and Sweepstakes ("Promotion") is sponsored by The Hain Celestial Group, Inc. ("Sponsor"), 221 River Street, 12th Floor, Hoboken, NJ 07030, and is administered by Twelve Thirty, LLC ("Administrator").

1. **PROMOTION PERIOD:** The Promotion begins at or about 12:00 PM (noon) Eastern Time ("ET") on May 13, 2024 and ends at 11:59:59 PM ET on September 7, 2024 ("Promotion Period"). The Promotion consists of an instant win game ("Game") and a sweepstakes ("Sweepstakes"), each of which must be entered separately, as described below. The Administrator's computer is the Promotion's official clock.
2. **ELIGIBILITY:** This Promotion is open only to legal residents of the fifty (50) United States who are at least eighteen (18) years old at the time of entry. Employees, officers and directors of Sponsor, Administrator, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, representatives, advertising, promotion and production agencies or agents (collectively, the "Promotion Entities") as well as their immediate family members (defined as including spouse; biological, adoptive, and/or step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) and persons living in the same household (whether related or not) of any of the above are not eligible to enter or win. Void where prohibited by law. All federal, state, and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical address or e-mail address on a submitted registration. Use of any automated system or any like methods to participate in the Promotion is prohibited and will result in disqualification of any entrant attempting such use.

3. **HOW TO REGISTER FOR THE PROMOTION:** During the Promotion Period, eligible entrants must visit www.SavorYourSummerSweepstakes.com ("Website") and enter their valid e-mail address. The entrant must then complete and submit the registration form with all required information, which may include, but may not be limited to, first and complete last name (no initials), phone number, street address (no P.O. Boxes will be allowed), city, state, ZIP Code, and date of birth. Upon successful completion and submission of the registration information, the entrant will then be able to proceed in the Promotion and select to participate in the Game and/or the Sweepstakes.
4. **HOW TO PLAY THE GAME:** After registering or submitting a valid e-mail address on subsequent days at the Website, the entrant must then follow the on-screen instructions to play the instant win game ("Game Play"). After the Game Play, the entrant will receive notification on the Website screen as to whether the entrant is a potential "Instant Winner"

("Notification"). Each entrant who receives a winning Notification will be deemed a potential Instant Winner subject to verification of the entrant's eligibility and compliance with these Official Rules, as determined by Sponsor and Administrator in their discretion. An entrant is not a winner of any prize, even if the Notification should so indicate, unless and until entrant's eligibility and the potential winning Game Play have been verified and entrant has been notified that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any Game Play that occurs after the system has failed for any reason is deemed a defective play, is void, and will not be honored.

LIMIT: There is a limit of one (1) Game Play per person/email address per day during the Promotion Period. In the event that a household enters the Promotion using more than five (5) unique e-mail addresses, all of the Game Plays associated with that household (as determined by Sponsor or Administrator in their discretion) may be disqualified. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Promotion Period, with the exception of May 13, 2024, when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET. If it is discovered or suspected that an entrant has registered or attempted to register for the Promotion more than once per calendar day using multiple e-mail addresses or multiple identities, all of that entrant's Game Plays will be declared null and void and any prize that he/she might have been entitled to win will not be awarded and will be revoked.

5. HOW TO ENTER THE SWEEPSTAKES: There are two (2) ways to enter the Sweepstakes:

A. Purchase Method: During the Promotion Period, purchase at least one (1) Hain Celestial qualifying product from the list found in the Appendix of these Official Rules from a participating retailer ("Qualifying Purchase"), while supplies last, and keep the original register receipt. Upon making a Qualifying Purchase, and after registering or submitting a valid e-mail address on subsequent days at the Website, the entrant must then follow the on-screen instructions to upload and submit a photograph of the Qualifying Purchase receipt ("Receipt"). Upon successful upload and submission of the Receipt, the entrant will receive one (1) entry into the Sweepstakes, subject to verification.

Receipt images may not exceed 10 MB, and must be in one of the following formats: PNG, JPG, or PDF. Receipt images must be legible and include the Qualifying Purchase date, retailer name, eligible products, and order total. An entrant may fold the Receipt to fit into one (1) image, provided the required information is visible. Receipts are subject to verification. A unique Receipt may only be used once to submit an entry into the Sweepstakes. The same Receipt may not be used by more than one (1) entrant. Mechanical reproductions, altered receipts, or unreadable receipts will not be accepted.

B. Free Method: To enter the Sweepstakes without making a Qualifying Purchase, an eligible entrant may hand-write their complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP Code, telephone number, and date of birth (MM/DD/YYYY) on a 3½"x5" card ("Mail-In Entry") and mail it with sufficient postage to: Savor Your Summer Sweepstakes Entry, 47 W Division St. #374, Chicago, IL 60610. All Mail-In Entries must be postmarked no later than September 7, 2024, and received on or before September 16, 2024, in order to be eligible. Each Mail-In Entry is worth one (1) entry into the Sweepstakes.

Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries mailed in an envelope or sent in excess of the entry limits set forth below

will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries

Note: submitting a Game Play as described above does not result in Sweepstakes entry.

LIMIT: There is a limit of one (1) Sweepstakes entry per person/email address per week, regardless of entry method. For purposes of this Promotion a “week” is defined as starting at 12:00 AM ET on Monday and ending at 11:59:59 PM ET on Sunday during a calendar week, with the exception of May 13, 2024, when the week starts at 12:00 PM ET.

6. RANDOM DRAWING: On or about September 17, 2024, the Administrator will randomly select one (1) potential Sweepstakes grand prize winner, one (1) potential Sweepstakes first prize winner, and ten (10) potential Sweepstakes second prize winners from among all eligible Sweepstakes entries received during the Promotion Period (“Random Drawing”). Each winner is considered a potential winner pending verification of their eligibility and compliance with the Official Rules.

7. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Game Prizes (130 total): The following prizes are available in the Game (each a “Game Prize”):

No more than one hundred thirty (130) Game Prizes will be awarded for any reason. If, due to a technical, production, human or other error, more than one hundred thirty (130) entrants receive a winning Notification, the one hundred thirty (130) intended Game Prizes will be awarded in a random drawing from among all recipients of such Notifications.

The total ARV of all Game Prizes is \$7,750.

B. Sweepstakes Grand Prize (1): The Sweepstakes “Grand Prize” is \$10,000 made payable to the Grand Prize winner, which may be used towards a vacation. Only one (1) Grand Prize will be available in the Sweepstakes. The ARV of the Grand Prize is \$10,000.

C. Sweepstakes First Prize (1): The Sweepstakes "First Prize" is \$3,000 made payable to the First Prize winner, which may be used towards travel and other expenses. Only one (1) First Prize will be available in the Sweepstakes. The ARV of the First Prize is \$3,000.

D. Sweepstakes Second Prizes (10): Each Sweepstakes “Second Prize” is \$500 made payable to the Second Prize winner. Ten (10) Second Prizes will be available in the Sweepstakes. The ARV of a Second Prize is \$500.

E. Total Sweepstakes Prize ARV: The total ARV of all prizes available in the Sweepstakes is \$18,000.

- F. **Odds of Winning:** The odds of winning a Game Prize depend on when the entrant completes a Game Play. Game Prizes will be made available at randomly predetermined times throughout the Promotion Period. To be a potential winner of a Game Prize, an entrant's Game Play must have occurred either at the exact randomly predetermined winning time as determined by Sponsor and/or Administrator. If a Game Play does not occur at the exact randomly predetermined winning time, then the next entrant's Game Play to occur after that time will be deemed a potential Instant Winner. The number of Game Prizes available to be won will decrease during the Promotion Period as Game Prizes are awarded and claimed.

The odds of winning the Sweepstakes Prize depend on the total number of eligible Sweepstakes entries received during the Promotion Period.

- G. **General Prize Conditions:** There is a limit of one (1) Game Prize per person/household during the entire Promotion Period. An entrant may win both a Game Prize and the Sweepstakes Prize. Details of Prizes will be determined by Sponsor in its sole discretion. All styles and sizes determined by Sponsor in its sole discretion. Use of a gift card is subject to the terms and conditions imposed by the issuer.

8. **HOW TO CLAIM A PRIZE:** All entrants who receive a winning Notification, as well as the potential Sweepstakes winners are each subject to verification of eligibility and compliance with these Official Rules. The potential Grand Prize and First Prize winners will each be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the associated prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. All potential Game Prize and Second Prize winners may be requested to provide additional documentation for verification purposes. Failure to provide all required documents and/or information within the stated time period may result in forfeiture of a winner's right to claim their prize. All potential winners will be notified by e-mail with instructions on how to claim a prize. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, or declines to accept a prize, the prize may be forfeited. Unclaimed Game Prizes will not be re-awarded. If a selected potential Sweepstakes winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept their Sweepstakes prize, or a Sweepstakes prize is returned as undeliverable, such Sweepstakes prize may be forfeited. If a Sweepstakes prize is forfeited for any reason, it may be awarded to an alternate potential Sweepstakes winner, at the Sponsor's sole and absolute discretion, selected at random from the remaining pool of eligible Sweepstakes entries received during the Promotion Period, time permitting. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Prizes will be mailed to verified winners at the street address provided at the time of registration within approximately eight (8) to ten (10) weeks from the end of the Promotion Period. Promotion Entities shall not be held responsible for any delays in awarding any prize for any reason. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any prize won. Sponsor will issue an IRS Form 1099-MISC for any winner of a prize valued at \$600 or more. Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered postal mail or e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Promotion email, including any winner notification email, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. The right to receive a prize is non-assignable, non-

transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize (or prize component) of equal or greater value in case of unavailability of a prize (or prize component) or the occurrence of a force majeure event, at Sponsor's sole and absolute discretion. ARVs are as of the time these Official Rules were printed and the actual retail value of a prize may fluctuate. A winner is not entitled to any difference between the ARV and the actual value of the prize at the time the prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. Each prize will only be awarded to a verified winner. Prizes that are unclaimed, unredeemed, or returned as undeliverable may not be awarded.

The Released Parties are not responsible for any incorrect or inaccurate information, whether caused by any Website users, tampering, hacking or by any of the equipment or programming associated with or utilized in the Promotion and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Website or any Promotion-related website(s). The Released Parties are not responsible for any injury or damage, whether personal or property, to participants or to any person's computer related to or resulting from participating in the Promotion and/or accepting or using a Prize.
